ORDER:

The Government of India have enacted the Right to Information Act, 2005 (Central Act 22 of 2005) to provide for setting up the practical regime of right to information for citizens to secure access to the information under the control of Public Authorities in order to promote transparency and accountability in the working of every Public Authority.

2. As per sub-section (4) of section 24 of the Right to Information Act, 2005, nothing contained in the Act shall apply to such Intelligence and security organization being organizations established by the State Government as that Government may, from time to time, by notification in the Official Gazette specify.

3. The Government have examined the report of the Director General of Police / Head of Police Force, Chennai sent in the letters first read above. In the Government Order second read above, orders have been issued formation of Anti-Terrorism Squad (ATS) in Tamil Nadu. After careful consideration, the Government have decided to specify the organization indicated hereunder in the notification as the organization for which nothing contained in the Right to Information Act, 2005 shall apply.

4. The following Notification shall be published in the Tamil Nadu Government Gazette Extraordinary, dated 23.02.2024:-

NOTIFICATION

In exercise of the powers conferred by sub-section (4) of section 24 of the Right to Information Act, 2005 (Central Act 22 of 2005), the Governor of Tamil Nadu hereby specify the Anti Terrorism Squad established by the Government of Tamil Nadu for which the said Act shall not apply.
