### ORDER:-

In the Government Order read above, Tmt B.Manjula, Additional Secretary to Government, Thiru V.M.Xavier Chrisso Nayagam IAS, Joint Secretary to Government, Tmt Parimala Boi, Deputy Secretary to Government have been designated as “Appellate Authorities” and Thiru P.V Muralidharn, Thiru MJJ Selvaraj Ebenezer, Thiru K.S.Kabaleeswaran and Thiru K.Kannan Under Secretaries to Government have been designated as “Public Information Officers” in respect of Animal Husbandry, Dairying and Fisheries Department, Secretariat, Chennai – 9

2. In supersession of the Orders issued in the G.O read above, the Government now appoint all the Under Secretaries to Government and the Deputy/Joint/Additional Secretaries concerned, Animal Husbandry, Dairying and Fisheries Department as the “Public Information Officers” and “Appellate Authorities” respectively, in respect of their Subjects/Sections and in respect of Sections, for which the Under Secretary post is vacant, the Under Secretary to Government (OP) is appointed as “Public Information Officer”.

3. The Public Information Officers/ Appellate Authorities will discharge the functions prescribed under the Right to Information Act 2005.

4. A Register should be maintained by the Public Information Officers / Appellate Authorities, in respect of the petitions received by them under Right to Information Act 2005 and this register should be submitted to the Principal Secretary, Animal Husbandry, Dairying and Fisheries Department on or before 5<sup>th</sup> of every month.

**5. The Public Information Officers shall furnish monthly periodical reports and Annual Reports under Section 25(3) of the Right to Information Act to A&C section for consolidation.**
