ORDER:

The Government of India have enacted the Right to Information Act, 2005 in order to provide the public, the right to access to Information about the administration and about the schemes of the Government implemented by various departments. The said Act provides for the notification of "State Public Information Officer" and the "Appellate Authority" for the purpose of carrying out the provisions of the Act. Accordingly, the Government in Prohibition and Excise Department appoint Tmt. R.Rama, Under Secretary to Government (Budget) and Thiru.G.Sankara Narayanan, Deputy Secretary (Preventive Detention) to Government as "State Public Information Officer" and "Appellate Authority" under the Act respectively. The following notifications are issued for publication in the Tamil Nadu Government Gazette: -

NOTIFICATION - I

Under Sub-section (1) of section 5 of the Right to Information Act, 2005, (Central Act 22 of 2005), the Governor of Tamil Nadu hereby designates Tmt. R.Rama, Under Secretary (Budget) to Government, Prohibition and Excise Department, Secretariat, Chennai - 600009 as the "State Public Information Officer" for the purposes of the said Act, in respect of Prohibition and Excise Department.
